

Prudential x Carousell Mid-Year Giveaway 2022

Terms & Conditions

1. Carousell Pte Ltd ("**Carousell**") and Prudential Assurance Company Singapore (Pte) Limited ("**Prudential**")'s Prudential x Carousell Mid-Year Giveaway campaign (the "Campaign") commences on 15 August 2022 and ends on 15 September 2022 (both dates inclusive) (the "Campaign Period"). All capitalised terms not otherwise defined herein shall have the meaning ascribed to the same in our [Terms of Service](#).

Eligibility

2. To participate in the Campaign and qualify as an eligible Carousell user (each, referred to as an "Eligible Carousell User" and collectively the "Eligible Carousell Users"), you must:
 - a. have an Account in Singapore; and
 - b. have completed the form located at <https://mediagroup.carousell.com/carousells-giveaway-sign-up-form/> ("Submission").
3. Carousell and Prudential will determine the six (6) winners of the Campaign (each a "Winner", collectively the "Winners") based on their response to the question(s) posted by Carousell via the form above ("Response").
4. Without limiting the generality of the above provision:
 - a. Carousell and Prudential reserves the right to draw a reserve winner to substitute the winner whose account is subsequently found to be suspended or terminated and/or if any Content has been removed in accordance with the Terms of Service. Eligible Carousell Users whose accounts are otherwise suspended or terminated due to a breach of Carousell's Terms of Service shall be disqualified and shall not be entitled to any payment or compensation whatsoever; and

General

17. These terms are subject to Singapore law and you hereby submit to the non-exclusive jurisdiction of the courts of Singapore.
